NEW BUSINESS

Authorizing the Transfer of Appropriated Funds Within the FY23-24 General Fund Budget. NBWA obtained a seasonal maintenance worker from the temporary employment agency to assist the field crew through the irrigation season. This temporary worker has shown a proclivity for the work and has attended training with Oregon Association of Water Utilities. With the training hours and training funds invested in the temporary worker, the Board recommends converting the temporary worker to permanent status. The FY23-24 budget allotted funds for a temporary seasonal worker but did not foresee the addition of a permanent worker to the field crew in FY23-24. This amount will be transferred from General Fund Contingency to General Fund Personnel Services.

The Accuity Representation letter was reviewed and approved by the Board.

MANAGER'S REPORT

<u>Irrigation:</u> Irrigation season is over. The ponds are still down so we can let them fill until at least November 1st, when we can pump into the river. The only thing that will delay that is if the river gauge at Foss reads less than 500 CFS. With the recent weather, that won't be a problem.

<u>River Gauge:</u> According to the Port of Nehalem, the USGS have decided the current location of the new river gauge will not work and have decided to move the new gauge to a piling near Nehalem Shores RV Park on North Road.

New Work Truck: The 2024 1500 Bighorn Lonestar has arrived and the 2005 Dodge will be added to the surplus list.

Vaccon: The new fun-size vaccon is in production. In the next week or two, it could be heading our way from Florida. Enviroclean will take it in and give it a full work over once it arrives in Estacada. The old full size vaccon did receive the new brain and modifications to the fuel pump and is currently working.

Carter Sewer Line Easement: The line was capped on Carter's property as of today. Carter has stated that he has approval for a septic system. We plan on capping the lateral at the mainline so that infiltration from the abandoned line will be negated.
